## KOHSHIN ELECTRIC'S GUIDELINES FOR ENVIRONMENTAL ACTIONS

We manufacture current sensors, measuring devices, power equipment, magnetic devices and other products, and supply them widely to domestic and overseas markets. In this sense, we play an important role in the conservation of biodiversity, including the realization of a low-carbon society through an effective and saving use of energy.

Among others, we regard environmental contribution as one of the most important missions in our business activities. Through the environmental actions introduced below, we work on the innovation for resolution to environmental issues, such as climate change, resource circulation and coexistence with nature and propose new mindsets to contribute to the realization of a sustainable future:

1. We strive to remain conscious of the biodiversity. We prevent the pollution in advance by accurately assessing the impact of our business activities, products and services on the environment. In addition, we improve our system of environmental conservation activities and environmental performance continuously.
2. We organize ourselves to reinforce the activities for environmental issues and maintain or even improve the environmental management system through self-management activities.
3. We raise awareness of environmental issues, by making our environmental policy fully known to all personnel working for our organization through environmental education and internal PR activities.
4. We comply with environment-related regulations, ordinances of prefectures, cities and towns and other requirements we agree to. Furthermore, we establish our own standards to the extent technically and economically feasible, and work to improve the environmental management levels.
